Barangaroo South: Tenancy carbon management

Customised our energy and carbon lifecycle platform for Lendlease, supporting their environmental goals for retail tenancy delivery. By implementing carbon management initiatives and developing retail design guidelines we achieved an annual reduction of over 3,590 tCO₂-e.



Australian National University (ANU): Kambri redevelopment

Conducted climate and embodied carbon assessments for the Kambri redevelopment masterplan accommodation 700 students, 7 buildings, public spaces, and 37 retail stores. Through early integration of carbon reduction into design and construction, a reduction of ~34,000 tCO₂-e in carbon, saving ~AUD\$1.3m and 6 weeks of time.



Investa: Capital works program decarbonisation pathway

Established Investa's capital works upfront carbon evaluation and decarbonisation strategy, implementing it across 30+ projects over the last 3 years. This resulted in a 400 tCO₂-e reduction from their capital works programme.
